With over 15 years' experience working in housing and within the community and voluntary sector in Northern Ireland, Kate previously worked in a grassroots human rights project focused on socio economic rights and has served on the Boards of a number of organisations in the sector. Her background is in law and human rights and she is especially interested in innovation to prevent homelessness and in the empowerment of marginalised groups.

Paddy Gray is an established academic and has wide experience of academic and applied research. He is currently an Ambassador for the Housing Safety and Well Being Task Force set up by Aico. Paddy Gray is an established academic with over 400 publications. In 2010 he became the first Irish President of the Chartered Institute of Housing (CIH). He is Chair of Wheatley Foundation in Scotland, and until recently was Vice Chair of Wheatley Homes Glasgow. In Ireland he Chairs Tuath Housing, and iCare Housing, and is a board member of Residential Tenancies Board (RTB). In NI he Chairs the Private Rented Tenants Voice and is a past Chair of Connswater Homes, Ulidia Housing Association and Citizens Advice North west. In 2017 he was named the top housing power player in the UK. 2019 awarded an OBE. 2021 appointed to the new Housing Commission in Ireland. 2023 was named Property Personality of the year at the Belfast Telegraph Property Awards and in 2024 he received a Lifetime Achievement Award at the Aico Communitiy Awards in Birmingham.



Minister for Communities, **Gordon Lyons MLA**

In February 2024 Gordon Lyons MLA was appointed as the Minister for Communities. His remit is wide ranging and covers housing, regeneration, sports, arts, culture, languages, libraries, museums, historic environment, benefits and pensions, community and voluntary sector, residential building safety, child maintenance services, tackling disadvantage and promoting equality of opportunity.

Gordon served as a Councillor on Mid and East Antrim Council from May 2014 to August 2015 when he was appointed as MLA for East Antrim and subsequently re-elected in 2016, 2017 and 2022.

In January 2020, Gordon was appointed to the Executive as a Junior Minister. He acted as Minister for Agriculture, Environment and Rural Affairs for a short period and was appointed Minister for the Department of Economy from July 2021 to October 2022.

Julie hopes to use this breakout session to inform the team's early thinking on the setting of Minimum Energy Efficiency Standards (MEES) for the Private Rented Sector.
